3. Police / City Warden Update:

# 5. Planning Matters:

The large (and welcome!) attendance by local residents was due to their concerns over the proposals for student and residential housing at the BT site by Froghall Terrace, outlined at a pre-application public consultation by GVA James Barr on 20<sup>th</sup> May 2015.

The apparent high density development (475 Student units in 4 & 5 storey blocks, plus a further 100 residential flats) raises concerns over: noise and loss of light/views in established homes on Froghall View, Sunnybank Road and Froghall Avenue; parking in neighbouring streets and developments; and insufficient local amenities and infrastructure to accommodate the population growth.

The well intentioned ideal of a car free development may be difficult to implement. Unauthorised parking in private housing estates (outwith public policing jurisdiction) such as the one off Sunnybank Road has been difficult to prevent. The shortfalls of the current CPZ were discussed.

Local residents have been in correspondence with local City Councillors for advice.

CK will write to GVA James Barr to ask for information for inclusion on FPSCC website to inform the wider public before the formal planning application stage.
